The form is used as a placeholder for a non-citizen's right to reside in the U.S. and is an important part of planning for international travel.

DS-160: Online Nonimmigrant Visa Application. The DS-160, Online Nonimmigrant Visa Application form, is for temporary travel to the United States, and for K (fiancé (e)) visas. Form DS-160 is submitted electronically to the Department of State website via the Internet. Consular Officers use the information entered on the DS-160 to process the visa application and, combined with a personal interview, determine an applicant's eligibility for a nonimmigrant visa.

Apply for or Retrieve Form I-94, Request Travel History and Check Travel Compliance International travelers visiting the United States can apply for or retrieve their I-94 admission number/record (which is proof of legal visitor status) as well as retrieve a limited travel history of their U.S. arrivals and departures.

U.S. Travel Documents Requirements: Traveling to and from ...

Application for Travel Document (Form I-131) can be used to apply for a re-entry permit, refugee travel document or advance parole travel document. Form I-131 should be submitted to U.S. Citizenship and Immigration Services and approved before overseas trip (including trip to Canada and Mexico).
